Alcoholic Beverage Server Permit

No Pouring Permit (aka Server Permit) shall be issued until such time as a signed application has been filed with the City Clerk or such department's designee and upon payment of a fee that shall be established by the City Council. A search of the criminal record of the applicant will be completed. Fingerprinting of the applicant for a Pouring Permit shall not be required if a valid driver's license is provided to the City. After application for the Pouring Permit is completed with the City, the employee may immediately commence work on a temporary basis provided the employee retains the receipt for the permit on his Person at all times at the Premises for which the Alcohol license has been issued, and thereafter if a permit is issued, must maintain on his Person at the Premises the actual Pouring Permit. For new employees, a receipt issued by the City Clerk may be used for a maximum of 30 days from the date of its issue. SERVER PERMIT / ACKNOWLEDGEMENT **FORM**

Please read the following and initial each h paragraph if you have read and understand. The information and regulations contained in this document are compulsory. You must understand and comply with all regulations which govern the establishment with which you are employed.

ALCOHOL BEVERAGE means and includes alcohol, distilled spirits, beer, malt beverages, wine, and fortified wine. 1. _____ FAILURE TO REQUIRE AND PROPERLY CHECK IDENTIFICATION. It shall be a violation not to require and properly check identifications for such person as reasonably necessary to ensure that no underage person is sold, served, or does not have in his/her possession alcoholic beverage. SALES TO UNDERAGE PERSON PROHIBITED. No employee authorized to sell alcoholic beverages shall do any of the following: Sell or offer to sell any distilled spirits, wine, malt beverage or other alcoholic beverage to any person under the age of 21 years. NO CONSUMPTION OUTSIDE PREMISES. It is prohibited for customers to leave the premises with open alcoholic beverages. BRING YOUR OWN BOTTLE (BROWN BAGGING) PROHIBITED. It is prohibited for any person to bring in his/her own alcoholic beverage to any establishment either licensed or unlicensed which serve alcoholic beverages. 5. HOURS AND DAYS OF SALE. Distilled spirits, beer, wine shall not be sold for consumption on the premises except between the hours of 10:00 a.m. through 1:00 a.m. Monday through Friday; and (10:00 a.m. (Saturday) -1:00 a.m. (Sunday)). PROMOTION AND SALES. No employee with the sale or other disposition of alcoholic beverage for consumption on the premises, shall offer free alcoholic beverages to any person or deliver more than one alcoholic beverage to one person at a time. 7. NO EMPLOYEE shall sell, offer to sell, or deliver alcoholic beverage, including malt beverage, in any container which HOLDS MORE THAN 32 FLUID OUNCES, EXCEPT TO TWO OR MORE PERSONS AT ANY ONE TIME. NO EMPLOYEE'S hall offer to sell any alcoholic beverages to any PERSON WHO IS NOTICEABLY INTOXICATED, who is of unsound mind, or who is a habitual drunkard whose intemperate habits are known. 9. INSPECTION OF ESTABLISHMENT BY THE CITY OF DAHLONEGA. Sworn marshal code enforcement officers of the City of Dahlonega shall have authority to inspect establishment licensed under the alcoholic beverage's ordinance of the City at any time.
